II. UNIVERSITY CLARIFICATIONS & RESPONSES TO QUESTIONS – Set No. 1

The following questions and associated responses were either submitted to the University Representative by prospective Consultants or are being offered by the University to clarify the requirements set forth in the Request for Qualifications. The University’s written responses hereunder are merely informational and do not qualify or otherwise amend the requirements set forth in the Request for Qualifications. In the event of a conflict between the information set forth below and the Request for Qualifications, the Request for Qualifications will prevail.

Question No. 1: On page 9 of the RFQ, within Tab 1 it states the list of projects proposers must provide should have been completed within the last 10 years. However, the SOQ form posted on the UCSB website states in question 7 on page 2 that the 5 major projects must have been constructed within the last 5 years. Please clarify?

University Response No. 1: Per the RFQ modification listed above (see Item No. 1-1), please submit a list of five major projects completed within the last ten (10) years.

Question No. 2: Is a letter required in response to the questions included at the top of page 11 under Tab 4, paragraph 3 entitled Malpractice Claims?

University Response No. 2: No. As detailed in that paragraph, it is sufficient to provide: (i) a list all malpractice claims adjudicated within the last five years for both the principal and its proposed subconsultants; (ii) a list of all pending and past lawsuits with the University of California; and (iii) a comprehensive list of all current and past projects with the University of California, regardless of claims or suits. Some overlap or redundancy of the information included in those listings is both likely and permissible.
