DESCRIPTION OF WORK:

Contractor is responsible for providing all labor and materials necessary for the prepping and painting of specified walls on the contract drawings. Contractor will be requested to provide a total of three (3) colors of paint. Paint color selections to be determined by the University Representative prior to the start of construction. All wall paint finishes are to be a semi gloss and all door and associated door frames to match existing finishes.

The date for completion of construction is May 31, 2013. The construction time of the project is of great importance to the University due to occupancy necessity. Accordingly, liquidated damages will be incorporated into the Construction Documents. Construction must be completed, in total, within the framework of a start date of April 24, 2013 and a completion on or before May 31, 2013.

Estimated Construction Cost: \$18,000

The successful Bidder and its Subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage rates at the location of the Work.
