DESCRIPTION OF WORK:

Contractor is responsible for providing all labor and material necessary for demolition of existing lighting fixtures, conduit, cabling, controls, drywall and all necessary finishes for the installation of new lighting fixtures. Install all new specified lighting fixtures and modify/install all associate controls as identified within the contract drawings and specifications. Responsible for all cutting, patching and painting to existing finishes. All surfaces shall be put back to their original conditions prior to demolition. Documentation and labeling shall be completed by the contractor and provided to the University Representative at the completion of the project.
