Subject to conditions prescribed by the University of California, Santa Barbara, sealed bids for a Lump Sum Contract are invited for the following Work:

Project Name: EH&S Rooftop Heating & Cooling Unit Replacement, Bldg. 565

Project No.: FM250097B/987109

Description of Work: Remove gas fired packaged rooftop air handling units numbered dx-1 through dx-6. Modify previously retrofitted equipment curbs for dx-1 and dx-3 as required to bring curbs back to original condition. Demolish natural gas piping on roof and cap at roof penetrations. Install new packaged rooftop heat pump air handling units on existing curbs. Replace air handler condensate piping and supports. Replace fused disconnects.

Estimated Construction Cost: \$316,340

Bid Security: Bid Security in the amount of 10% of the Lump Sum Base Bid shall accompany each Bid. The Surety issuing the Bid Bond shall be, on the Bid Deadline, an admitted surety insurer (as defined in California Code of Civil Procedure Section 995.120).

General Project Information: The successful Bidder and its Subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage rates at the location of the Work.

The successful Bidder will be required to have the following California current and active contractor's license at the time of submission of the Bid:
