Project Name: North Hall Bike Path and Parking Expansion Project (REBID)

Project No.: FM240482SR/987081

Description of Work: The North Hall Bike Path and Parking expansion project will include a wider path to allow for dismount areas for safe turns into the two bike parking areas. The existing bike parking area asphalt is badly damaged and will be replaced with porous asphalt. This project will expand the total number of parking spaces from 286, which are only on the western side of the bike path, to 560.

Estimated Construction Cost: \$673,056.00

Bid Security: Bid Security in the amount of 10% of the Lump Sum Base Bid shall accompany each Bid. The Surety issuing the Bid Bond shall be, on the Bid Deadline, an admitted surety insurer (as defined in California Code of Civil Procedure Section 995.120).

General Project Information: The successful Bidder and its Subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage rates at the location of the Work.

The successful Bidder will be required to have the following California current and active contractor's license at the time of submission of the Bid:
