GENERAL

The following changes, additions or deletions shall be made to the following document(s) as Indicated; all other conditions shall remain the same.

I. SPECIFICATIONS

Item No.

1-1 Section 015⁷0 - "Traffic Control": "3.03 Road Closure Conditions":

Add the following paragraph:

"E. Contractor shall at minimum maintain one vehicle lane and one bike lane in each direction open at all times. Fire and emergency vehicles shall be allowed open access at all times unless otherwise approved by the University or County of Santa Barbara. Access into Isla Vista School and other adjacent properties shall be maintained open at all times, and also follow any additional requirements from the County in the encroachment permit. Contractor shall be responsible for providing manpower and facilities for implementing the approved traffic control devices."

- 1-2 <u>Section 01080 "Regulatory Requirements"; "1.03 Permits and Notifications"</u>: Add the following paragraph:
 - "I. Encroachment Permit: Contractor shall obtain an encroachment permit from the County of Santa Barbara for work within the County right of way.
