DESCRIPTION OF WORK: Perform friable asbestos abatement, non-friable asbestos abatement, lead-related construction tasks, clean demolition of building components and general demolition of building components. Contractor will be performing work in both occupied and un-occupied buildings.

JOC will only be used to support larger construction projects that have a total estimated cost of work equal to or in excess of \$50,000 and have an asbestos containing material, Pb containing material and/or water damaged material removal component as part of the overall construction of the work ("Hazardous Work"). This JOC is to be used when the Hazardous Work can be treated as a stand alone component of the overall project.

The minimum amount for an individual Job Order is \$50,000. The maximum Job Order Contract amount for all Job Orders during the course of the initial one-year contract term is \$200,000, with two separate one-year options, if exercised, for \$200,000 each. The annual Job Order Contract amounts are not cumulative.
