SECTION 01020 ALLOWANCES

PART 1. GENERAL

1.01 DESCRIPTION

A. Included in the Contract Sum are all Allowances stated in the Contract Documents. Items covered by Allowances shall be supplied for such amounts and by such persons or firms as University's Representative may direct.

1.02 APPLICATION

The following shall apply, unless otherwise provided in the Contract Documents:

- A. Allowances shall cover the cost to Contractor of: materials and equipment delivered at the Project site and all required taxes, less applicable trade discounts.
- B. Contractor's costs required for storage on and off the Project site; security; loading and unloading; handling at the Project site; labor; installation costs; overhead; profit; and other expenses necessary for the stated Allowance amounts shall be included in the Contract Sum and not in the Allowances.
- C. Whenever costs are more than or less than Allowances, the Contract sum shall be adjusted by Change Order based on (1) the difference between actual costs and the Allowances and (2) changes in Contractor's costs.
- D. At any time during the course of the Contract, the University's Representative may elect to delete any or all allowances via Change Order for the full amount listed below.
