PART 1 - GENERAL

1.01 IDENTIFICATION OF ALTERNATES

- 2.1 This Section identifies each Alternate and describes basic changes to the Work only when that Alternate is made a part of the Work by specific provision in the Agreement.
- 2.2 The Lump Sum Base Bid and Alternates shall, unless otherwise specified, include the costs of products, materials, equipment, systems, installation and all supporting elements required, so that the combination of the Lump Sum Base Bid and any Alternates shall be complete. The scope of Work for all Alternates shall be in accordance with applicable Drawings and Specifications.
 - A. Except as otherwise specifically provided by the University, the Work described in Alternates shall be completed with no increase in Contract Time.
- 2.3 This Section includes only the non-technical descriptions of the Alternates. Refer to the specific Sections of DIVISIONS 2 16 of the Specifications for technical descriptions of the Alternates.
- 2.4 Coordinate related Work and modify surrounding Work as required to properly and completely integrate the Alternates into the Work.

PART 2 - DESCRIPTION OF ALTERNATES

2.01 ALTERNATE NO. 1:

- A. Provide additional panels, supports, wiring, connections, and all other necessary materials and labor sufficient to provide an additional 10 KW, for an installed system of 100 KW as specified in Section 13650, "Photovoltaic System."
 - 1. If this Bid Alternate is accepted, the Contract Time will not be extended.
 - 2. University reserves the right to accept this Alternate within thirty (30) days after the Agreement.

2.02 ALTERNATE NO. 2:

- A. Provide additional panels, supports, wiring, connections, and all other necessary materials and labor sufficient to provide an additional 20 KW, for an installed system of 110 KW as specified in Section 13650, "Photovoltaic System."
 - 1. If this Bid Alternate is accepted, the Contract Time will be extended by ten (10) days.
 - 2. University reserves the right to accept this Alternate within thirty (30) days after the Agreement.

2.03 ALTERNATE NO. 3:

- A. Provide additional panels, supports, wiring, connections, and all other necessary materials and labor sufficient to provide an additional 30 KW, for an installed system of 120 KW as specified in Section 13650, "Photovoltaic System."
 - 1. If this Bid Alternate is accepted, the Contract Time will be extended by twenty (20) days.
 - 2. University reserves the right to accept this Alternate within thirty (30) days after the Agreement.

2.04 ALTERNATE NO. 4:

- A. Provide additional panels, supports, wiring, connections, and all other necessary materials and labor sufficient to provide an additional 40 KW, for an installed system of 130 KW as specified in Section 13650, "Photovoltaic System."
 - 1. If this Bid Alternate is accepted, the Contract Time will be extended by thirty (30) days.
 - 2. University reserves the right to accept this Alternate within thirty (30) days after the Agreement.
