1. **ADD No. "11" to read as follows:**  
11. INSTRUCTIONS TO BIDDERS ("ARTICLE 4 – PREBID CONFERENCE") :

A. Amend paragraph 4.1 to read as follows:

“Bidder shall attend the Pre-Bid Conference at which the requirements of the Bidding Documents are reviewed by University, comments and questions are received from Bidders. University requires all Pre-Bid Conference attendees to arrive for the meeting on time and to sign an attendance list, which in turn is used to determine if Bidders meet this requirement.
