The manufacturer (including fiber extrusion, tufting, and coating) shall be the same corporate entity that provides the warranty for the synthetic turf system to the University.

The synthetic turf manufacturer shall have produced and installed a minimum of thirty-five (35) outdoor in-filled fields of full size within the past two (2) years with the same layered sand and rubber infill composition as required under the Bidding Documents.

The Installer of the synthetic turf system must have installed a either: (1) a minimum of ten (10) in-filled synthetic turf football or soccer fields of full size within the past two (2) years; or (2) a minimum of twenty (20) in-filled synthetic turf football or soccer fields of full size within the past five (5) years. The installer shall have installed a minimum of five (5) successful in-filled synthetic turf football or soccer fields of full size for the product manufacturer.

The synthetic turf surfacing system vendor shall have a designated employed representative available for service based in the State of California.
