Construction Services will include, but not be limited to, seismic calculations, product shop drawings and submittals, coordination with other on-site contractors, and all scheduling/phasing of work.

The successful Bidder will be required to have the following California current and active contractor's license at the time of submission of the Bid:

or
- (2) D-24 METAL PRODUCTS CONTRACTOR  
or
- (3) D-34 PREFABRICATED EQUIPMENT CONTRACTOR
