Project Name: Music Building Unit 1 Seismic Improvements

<u>Project Description:</u> Statements of Qualifications submittals are hereby solicited by the University of California, Santa Barbara ("University") from design professionals and firms with relevant experience and expertise in providing the services described herein. The selected consultant will provide design services associated with the Music Building Unit 1 Seismic Improvements project ("Project"), as more fully described in this Request for Qualifications ("RFQ") No. FM210197.

The Project includes the architectural integration of seismic improvement work with existing architecture and systems housed within approximately 38, 000 GSF of UCSB Building 531, which is located in the core area of the University of California, Santa Barbara campus. It is anticipated that The Project may trigger code required compliance and associated improvements within the disciplines of accessibility and fire life safety.

Estimated Construction Cost: The overall construction budget is approximately \$10,200,000.

Scope of Services: While conceptual seismic improvement measures are proposed in a recent Seismic Evaluation & Conceptual Rehabilitation Study conducted by Degenkolb Engineers, the University is seeking an architectural and engineering team familiar with remodeling and/or seismic retrofitting work to cohesively integrate seismic improvements within the context of the international/modernist genre of Pereira & Luckman's design in an effort to retain the original design intent of the Music Building. It is anticipated that the Project will include a modest scope of deferred maintenance work, as well as upgrades to accessibility and life safety systems that will be triggered by the scope and construction cost of the seismic improvements.

The professional scope of services for this project will include phases for architectural and engineering design of the project, including cost estimating, code analysis, value engineering, project scheduling, and coordination with Campus personnel and other stakeholders, culminating in completed construction documents issued for competitive bids. Construction phase services will include submittal reviews and field representation.

The scope of professional services will include review and validation of project scope, architectural and engineering design services of the Project and the preparation of construction documents with updated cost estimates, administrative support services during the project, bidding assistance and construction phase administrative services and as built documentation under the University's standard Executive Design Professional Agreement (See RFQ Exhibit B).

While State funding had been secured for this Project, there is no assurance that the project will be pursued, should it be determined that the Project significantly exceeds the Approved cost as understood by The Regents.

<u>Instructions for Applicants</u>: Qualified professionals and firms possessing relevant experience and expertise in providing design services for projects similar in scale, size and scope are encouraged to respond to this RFQ.
