Project Name: Cabrillo Business Park Communications Line Phase 2/Phase 3 Archeological Study

Project Description: Statements of Qualifications submittals are hereby solicited by the University of California, Santa Barbara ("University") from cultural resources consulting firms with relevant experience and expertise in providing the services described herein. The selected consultant will provide Phase 2/Phase 3 archeological resources studies associated with the Cabrillo Business Park Communications Line project ("Project"), as more fully described in this Request for Qualifications ("RFQ") No. FM230093.

The Project includes installation of an approximately 725-foot communication line from an existing pull box on University property at Los Carneros Road and Discovery Drive to existing conduit infrastructure in the center of University property at Discovery Drive. The first approximately 150 feet would be installed under Los Carneros road, by boring, to a pull box on University property and continue by open trenching approximately 575 feet from that pull box to the existing business park conduit infrastructure. Trenching would be through asphalt and be approximately 24 inches wide by 36 inches deep. A portion of the trenching would be through an identified sensitive archaeological area.

Estimated Construction Cost: The overall construction budget is approximately \$300,000.

Scope of Services: The scope of services shall include, but not be limited to, conducting a Phase 2 archeological site investigation, and a subsequent Phase 3 study if significant deposits are encountered. Work includes field preparation, including any necessary records search, coordination with the Native American Heritage Commission and local Native Americans. Field work includes removal and replacement of asphalt to conduct the Phase 2 investigation.

The scope of services includes typical operations to conduct a Phase 2 investigation including, but not limited to, installing augers and excavation units, screening deposits, laboratory processing, a technical analysis and report and, if necessary, a Phase 3 investigation.

In addition to conducting a Phase 2/Phase 3 archeological study to determine the extent of the archeological site, once analysis is complete, archeological monitoring will be required during the communication line installation.

While it is anticipated that funding will be obtained, there is no assurance that funds will be received for the project noted. Selection of the professional consultant will follow standard University procedures.

Instructions for Applicants: Qualified professionals and firms possessing relevant experience and expertise in providing archeologic resource investigation services for projects similar in scale, size and scope are encouraged to respond to this RFQ.
