

## **ADVERTISEMENT FOR BIDS (PREQUALIFIED GCs)**

Subject to conditions prescribed by the University of California, Santa Barbara, sealed bids for a Lump Sum Contract are invited for the following Work:

Project Name: San Clemente Villages Student Housing Renovation – Phase II

**Project No.**: FM230193L/982040

**Description of Work:** Contractor shall provide all labor, materials, equipment, tools, transportation, insurance, and services to renovate graduate student housing apartment units located at San Clemente Villages. The units are a mixture of 4 bedroom/2 bathroom, 2 bedroom/1 bathroom, studio, and loft apartment type units. The project includes 203 apartment units, several common areas, and a housing office located in the Arrowhead, Bradbury, and Castaic Villages. Approximately 175,000 total assignable square feet included in this project. The work also includes exterior ADA accessibility work throughout Castaic, Bradberry, and Arrowhead Villages. This interior refurbishment project includes the removal and replacement of flooring, kitchen countertops, cabinetry modifications and repairs, toilet and bath accessories, appliances, minor plumbing, plumbing fixtures, shower enclosure repair, light fixtures, light switches, life safety repairs, door and window hardware repair, removal and replacement of window treatments, a complete interior re-paint with added accent walls, exterior window cleaning and pressure washing of hardscape exterior, handrail extensions and ADA compliant trash chute pulls, and the reconfiguration and renovation of an office space within the complex, per the plans and specifications.

All existing furniture will be removed by the University. All new furniture will be furnished and installed by the University during the performance period specified in paragraph below. The renovation project will commence immediately on June 26, 2023 and shall be completed by September 11, 2023. Given the high quantity of work to be completed over the allotted length of time, Contractor will be expected to work weekends and possibly double shifts as needed to execute the scope of work. These apartment complexes will be completely vacant, the contractor will have full access to the buildings during the project. Comply with the requirements of "Section 01 14 00 - Work Restrictions"

**Estimated Construction Cost**: \$8,099,565
