The total estimated value for the individual University projects will be in the range of \$2,500 to \$45,000 with a maximum contract sum that is not to exceed \$300,000 for the 3-year contract term; however, the selected consultant(s) are not promised any minimum commitment of work by the University.

The University may, at its sole discretion, select and enter into an indefinite delivery/indefinite quantity agreement with up to five (5) consultant firms. Project services will be awarded to the selected firms based upon availability, workload, capacity, demonstrated expertise/experience, the relevant scope, scheduling issues, etc. While it is anticipated that funding will be obtained, there is no assurance that funds will be received for the anticipated projects. Selection of the consultant(s) will follow the University of California qualifications-based selection procedures. The selection criteria for this project will be detailed in the Request for Qualifications.
