Subject to conditions prescribed by the University of California, Santa Barbara, sealed bids for a Lump Sum Contract are invited for the following Work:

Project Name: Embarcadero Hall Air Handler Modernization, Bldg. 941

Project No.: FM240242S/100-40

Description of Work: Contractor shall provide all labor, materials, equipment, tools, transportation, insurance, and services to replace seven (7) gas-electric rooftop AHUs with seven (7) heat pump units in like kind with minor ductwork modifications to facilitate the installation of the new units and new vibration isolation bases. The sheet metal caps below the rooftop units will also be replaced, all existing gas piping will be demolished and capped at roof entrance, all existing condensate piping on the roof will be replaced, as described in the Construction Documents. The work will be performed during the summer of 2024.

Estimated Construction Cost: \$525,000

Bid Security: Bid Security in the amount of 10% of the Lump Sum Base Bid shall accompany each Bid. The Surety issuing the Bid Bond shall be, on the Bid Deadline, an admitted surety insurer (as defined in California Code of Civil Procedure Section 995.120).

General Project Information: The successful Bidder and its Subcontractors will be required to follow the nondiscrimination requirements set forth in the Construction Documents and to pay prevailing wage rates at the location of the Work.

The successful Bidder will be required to have the following California current and active contractor's license at the time of submission of its Bid:
