**Project Name:** Phelps Hall Replace Terminal and Package Units, Bldg. 560

**Description of Work:** Contractor shall provide all labor, materials, equipment, tools, transportation, insurance, and services to replace two roof-top exhaust fans (EF-1 & EF-2) in the NW tower's mechanical penthouse, and associated ductwork, VFDs and controls. Storage of material by the University is not available. All staging and lay-down areas, including adjacent roof top areas must be protected and restored to their original condition.

**Estimated Construction Cost:** \$250,000

**Bid Security:** Bid Security in the amount of 10% of the Lump Sum Base Bid shall accompany each Bid. The Surety issuing the Bid Bond shall be, on the Bid Deadline, an admitted surety insurer (as defined in California Code of Civil Procedure Section 995.120).

**General Project Information:** The successful Bidder and its Subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage rates at the location of the Work. The successful Bidder will be required to have the following California current and active contractor's license at the time of submission of the Bid:
