Subject to conditions prescribed by the University of California, Santa Barbara, sealed bids (Best Value Selection) for a CM-at-Risk contract are invited for the following work:

**Project Name:** UCSB East Campus Student Housing

**Project Number:** FM240486L

**Summary of Work:** UCSB East Campus Student Housing project, located on the main UC Santa Barbara campus, is envisioned as a new LEED Platinum residential community, inclusive of residence hall and apartment style unites, amenities and gathering opportunities, and an inclusive dining facility. UCSB East Campus Student Housing has a program goal of approximately 1687 student beds, dining, and various support spaces, within approximately 582,500 gross square feet - across multiple buildings and room types. Situated on roughly 10.6 acres of developable area, the project will require the rerouting and extensions of new and existing utilities – both onsite and offsite, protecting the existing occupied residence halls and academic buildings from noise and debris, mitigating pedestrian, vehicle and cyclist traffic, and managing the phasing of demolition and new construction.

**Estimated construction cost:** \$445,000,000

**ONLY PREQUALIFIED CM/GENERAL CONTRACTORS WILL BE ALLOWED TO SUBMIT A PRIME CM/GC BID ON THIS PROJECT.** The following firms have been prequalified to bid on this project:

2. PCL Construction Services (Glendale, CA)

The successful bidder will be required to provide both Phase 1 Pre-Construction Services (e.g., design assist, estimating, constructability, site logistics, development of trade packages (including selected design-build / design assist packages), buy out/ bidding and, if awarded, Phase 2 Construction Services (i.e., management and coordination of the construction Work). Phase 2 services shall be exercised at the University's sole option. The University has hired Skidmore Owings & Merrill who has partnered with Mithun to program and design the project. A Detailed Project Program is still underway and Schematic Design is anticipated to begin in September of 2024, with an anticipated Construction demolition start of April 2026 and a Construction Completion of July 2029.

## **GENERAL PROJECT INFORMATION**

The methodology used to determine Best Value as part of the competitive bidding process will be described in the Construction Documents. The University will use a Best Value selection methodology to determine the apparent lowest responsive bidder. The Best Value to the University will be determined by using objective criteria described in the Bidding Documents with the resulting selection representing the best combination of both price and technical qualifications.

The University shall pay for, obtain and maintain a University Controlled Insurance Program ("UCIP") providing workers' compensation and employer's liability insurance coverage, commercial general liability insurance coverage, and excess liability insurance coverage, to all GC and subcontractor personnel enrolled in the UCIP for Work performed on or at the Project site. The Contractor and its subcontractors are required to cooperate with the University of California and its UCIP Administrator in all aspects of UCIP implementation and administration. UCIP coverages shall apply only to the Work of each Enrolled Party performed on or at the Project site, and only to Enrolled Parties eligible for the UCIP. Enrollment in the UCIP is mandatory for all Eligible Parties. In addition to the insurance provided under the UCIP, Enrolled Parties shall obtain and maintain, and shall require each of their Subcontractors of all tiers to obtain and maintain, the insurance coverage specified in the Construction Documents.

Every effort will be made to ensure that all persons shall have equal access to contracts and other business opportunities with the University within the limits imposed by law or University's policy. Each Bidder may be required to show evidence of its equal employment opportunity policy. The work described in the contract is a public work subject to section 1771 of the California Labor Code. No contractor or subcontractor may be listed on a Bid for this project unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 [with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a)].
