**Description of Work:** Provide all labor, materials, equipment, tools, transportation, insurance, and services for the creation of four separate areas; a clean room, a wet lab, a balance room, and an instruments lab. There will be new poly and powder coated steel lab casework, two RPO stations, compressed air, natural gas, and n2 gas stations throughout, a new emergency eyewash station, a Perchloric hood and exhaust system.

Estimated Construction Cost: \$990,000
