Project Name: Woodhouse Geochemistry Lab Renovation, Bldg. 546

Description of Work: Provide all labor, materials, equipment, tools, transportation, insurance, and services for the creation of four separate areas; a clean room, a wet lab, a balance room, and an instruments lab. There will be new poly and powder coated steel lab casework, two RPO stations, compressed air, natural gas, and n2 gas stations throughout, a new emergency eyewash station, a Perchloric hood and exhaust system.

Estimated Construction Cost: \$990,000

General Project Information: The successful Bidder and its Subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage rates at the location of the Work.
