Project Name: University Center 3rd Floor Tenant Improvements, Bldg. 558

Description of Work: Provide all labor, materials, equipment, tools, transportation, insurance, and services to construct an interior tenant improvement on the third floor of the UCSB University Center Building 558, to include partial interior demolition, non-bearing metal stud wall partitions to create three (3) offices. Project scope also includes window replacements, built-in casework with solid surface countertop and integrated sink, window shades, and modifications to ceiling to accommodate office layout, painting, carpeting, LVT flooring, and an ADA compliant drinking fountain with bottle filler, related mechanical, plumbing, electrical, fire sprinkler modifications, and hazardous material abatement, as described in the Construction Documents.

Estimated Construction Cost: \$669,366

Bid Security: Bid Security in the amount of 10% of the Lump Sum Base Bid shall accompany each Bid. The Surety issuing the Bid Bond shall be, on the Bid Deadline, an admitted surety insurer (as defined in California Code of Civil Procedure Section 995.120).

General Project Information: The successful Bidder and its Subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage rates at the location of the Work.
