**Description of Work:** Provide all labor, materials, equipment, tools, transportation, insurance, and services for the above-mentioned project, including but not limited to the following:

The Work includes an interior renovation of 1,232 square feet of the University's Broida Hall building in rooms 1302 and 1310. These improvements enhance the capability of the existing laboratory space to house laboratory equipment used in optics experiments, and provide a dedicated office space for use by researchers. Work in the mechanical core of Broida Hall includes adding a mechanical platform to support current and future laboratory equipment and infrastructure, as well as additional lab equipment and infrastructure between the catwalk and mechanical core wall and penetrations between the renovated lab and core.

Estimated Construction Cost: \$415,000

The successful Bidder will be required to have the appropriate State of California Contractor's license(s) current at the time of submission of the Bid.
