The successful proposer and its subcontractors will be required to follow the nondiscrimination requirements set forth in the proposal documents and to pay prevailing wage rates at the location of the work.

The successful proposer will be required to have the following California contractor's license at the time of the proposal opening:

Proposer Qualifications:

Proposers who do not meet the qualifications as specified in the Proposal Documents will not be eligible for award. Proposers shall submit their qualifications on the form provided by the University as an attachment to the Bid Form. The Proposer (Contractor) shall have been in business under the same name and California Contractor's License for a minimum of two (2) continuous years prior to the bid opening date for this Project. The license used to satisfy this requirement shall be of the same type required by the contract. The Proposer shall provide a minimum of three (3) references for projects similar in scope and size to this Project which have been successfully completed during the past two (2) years.

The University's estimate of the cost of design and construction is \$125,000.00 The maximum acceptance cost is \$200,000.00. The contract for this project will be awarded to the Proposer submitting the lowest responsive lump sum proposal for the work of the said project.
