I. QUALIFICATION QUESTIONNAIRE

1. GENERAL INSTRUCTIONS

As used herein, the term “entity” means the prospective Design-Build Proposer submitting this Qualification Questionnaire regardless of whether the entity is an individual company, joint venture, or partnership.

Each prospective Proposer must provide a response to all of the following questions and provide all requested information. Any prospective Proposer failing to do so may, at the University’s sole discretion, be deemed “non-responsive” to the requirements of the RFP, thereby eliminated from further consideration the competitive process.

Proposals will only be considered from Proposer who have submitted a Qualification Questionnaire at or before the proposal deadline date set forth in the RFP and meet the minimum requirements contained herein.

If the prospective Bidder is determined by the University to be “not qualified” to bid the subject project, the prospective Bidder may request a review by the University. Any such request must be received by the University within 3 calendar days after receipt by the prospective Bidder of the determination. The decision resulting from such review is final and is not appealable within the University of California. Any person or entity not satisfied with the outcome of the qualification must file a writ challenging the outcome within 10 calendar days from the date of the University's written notice regarding qualification determination. Any assertion that the outcome of the qualification process was improper will not be a ground for a bid protest.

All information submitted for qualification evaluation and marked as “confidential” will be considered official information acquired in confidence, and the University of California will maintain its confidentiality unless (1) the University determines that it is required to release the information to a third party pursuant to the requirements of the California Public Records Act or (2) the University is required by court order to release the information to a third party pursuant to the requirements of the California Public Records Act.

All other information submitted for Qualification evaluation will be considered official information acquired in confidence, and the University will maintain its confidentiality to the extent permitted by law.
