LEVEL 2 EVALUATION & PROJECT INFORMATION

A request for the submittal of supplementary prequalification materials- including a preliminary staffing proposal- from Level 1 Prequalified firms and the provision of additional details regarding the interview and mandatory site visit phases of the Level 2 Prequalification process will be forwarded to each of the listed firms by the University under separate cover on December 7, 2012. The December 7th correspondence will provide each firm with details regarding Level 2 Prequalification scoring criteria and the location, time and content of firm interviews.


The mandatory Level 2 Site visit will take place on the UCSB campus on December 11, 2012 at 8:30 a.m. in the Fiesta Room at the Santa Catalina Dorms, South Tower. The street address is 6850 El Colegio Road at the intersection of Storke Road. Parking is available by visitor permit in Lot #58 adjacent to the meeting location. Each firm's proposed Project Manager and Project Superintendent must attend the mandatory Level 2 Site Visit. Please limit firm attendees to no more than four (4) people. Any Level 1 Prequalified firm that does not attend the mandatory Site Visit will be eliminated from further consideration in the prequalification process.

In anticipation of Level 2 interviews and the site visit, Prospective Bidders must familiarize themselves with the 50% plans and specifications provided by the University via "Dropbox" under the following link:
