The estimated project construction budget is in the \$1.6M to \$2M range.

The planned start date for construction services is August 2015.

Scope of Services

Provide exterior lighting/electrical design, limited planting and irrigation design, bidding and limited construction administrative services for the design of the relocation of UCen Road, 4 new bike parking lots, one new car parking lot, and the expansion of an existing parking lot. Design plans must be compatible with UCSB standards.



Provide design of new lighting at four (4) new bike parking lots and one new car parking lot. Design to be per UCSB lighting standards.
- Using the existing 90% construction documents revise the existing planting and irrigation drawing and specifications to provide planting and irrigation design per the already revised civil drawings for added drainage swales next to Bike Parking Lots W, X, and Y.
- 3. Provide bidding and limited construction administrative services for the UCen Road Realignment project which includes the of the relocation of UCen Road, four (4) new bike parking lots, one (1) new car parking lot and the expansion of an existing parking lot.
