Advertisement

Project Description

Qualifications are hereby solicited from construction management professionals interested in providing services for the construction management of **Mosher Alumni House**. The new facility is a four level mixed use occupancy, and will house the Alumni Association offices that are currently off campus. The new structure is steel frame with CMU and metal stud walls. The exterior is a composite cladding system and stone veneer. The first level is designated for storage and future office space (9,582 s.f. gross area). The second level is designated for assembly areas and office space (7,115 s.f. gross area). The third level is also designated for assembly areas and office space (5,728 s.f. gross area). The fourth level (roof) is designated for observation deck (681 s.f. useable, 6,214 s.f. gross area.) The current projected construction budget is approximately \$7,000,000.00. The planned date for completion of construction is Summer 2006.

Scope of Services

The scope of professional services will be review and evaluation of Design Professional's documents through out their development, estimates of probable construction cost, value engineering, constructibility review, scheduling and schedule management, cost management, development and evaluation of Scopes of Work, analysis and recommendations of contracting methodology, assembly of bid packages, prime contractors acquisition and management, quality control, administration of construction contracts as agent for University, and other services as may be required to facilitate the successful completion of the project.

Construction Management teams with qualifications that include experience in the construction management of projects similar in scale and scope are encouraged to respond. The current projected construction budget is approximately \$7,000,000.00. The planned date for completion of construction is Summer 2006.

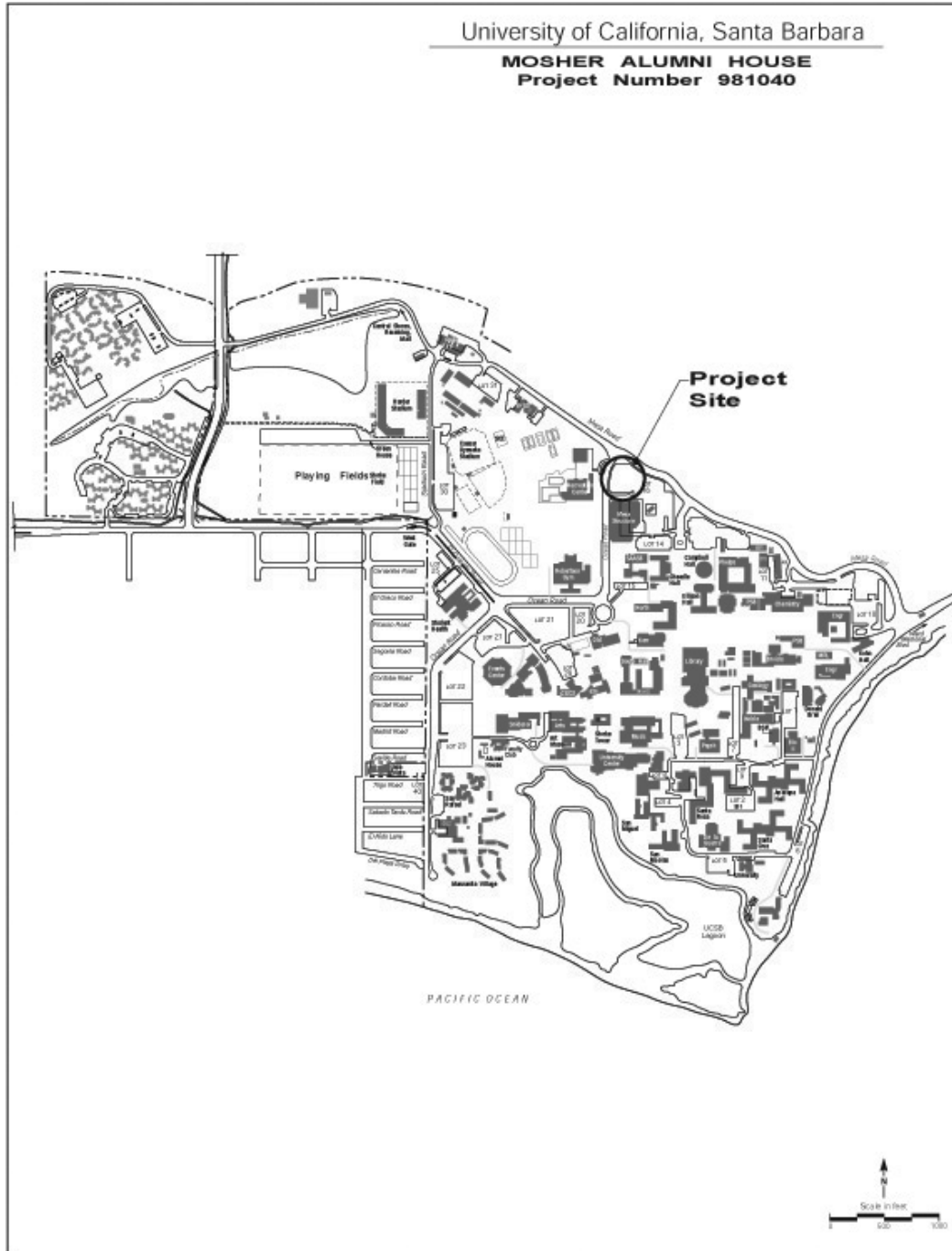

1. Respond concisely to the Selection Criteria and complete the Statement of Qualifications Form. A list of projects of similar scope, complexity, and cost will be essential to a successful application. The Statement of Qualifications must be signed by a responsible member of the firm applying for the project.
2. Include supplementary information supporting qualifications (8 ½ x 11 format). Organization and brevity will be appreciated. Work submitted as an example of the design team's qualifications will be considered only to the extent it is similar to the proposed project. Additional information may be submitted demonstrating experience in programming, planning and design on university campuses. Identify the engineering team and consultants for all projects listed as examples of your firm's work. Provide information on proposed engineering staff and consultants for this project and an organization chart. Provide a list of previous projects the proposed team has participated in together.

4. Submit **six (6)** copies of all material bound into single documents.
5. Due Date: **February 22, 2005**, no later than **5:00 p.m.**
6. Construction Management teams with qualifications considered appropriate by the Screening Committee will be asked to submit detailed proposals for consideration by the Selection Committee.



Selection Criteria

1. ***Construction Management.*** Evidence of ability to provide all required services including schedule management, cost management, development and evaluation of scope of work, estimates of probable construction cost, value engineering, analysis and recommendation for contracting methodology, quality control and administration of construction costs.
2. ***Project Management.*** Proven management expertise with quality control, schedule and budget management of projects of similar size and complexity. Ability to provide efficient and comprehensive project management for all phases of the project, with particular emphasis placed on the capability to work in partnership with University staff, consultants, and contractors during design and construction. Demonstrated track record of meeting budget and schedule requirements. Great emphasis will be placed on proven ability to deliver projects within budget and on schedule.
3. ***University Experience.*** Proven experience that demonstrates success in completing projects in the University of California system. This experience must be demonstrated for specific personnel proposed for assignment to this project. Construction Manager must have experience in managing projects in the University of California system using the Multiple Prime Contract delivery method.
4. ***Team Organization and Approach.*** Clear and appropriate definition of roles. Project implementation approach tailored to the special needs of this project.
5. ***Equal Opportunity.*** The commitment of the University to equal opportunity applies to the selection of construction management professionals.
