**PROJECT NAME:** North Campus Open Space Bridges (UFCI)

**RFB NUMBER:** FM170375UF/986200 (Fed-aid #ATPL-6300 (003))

**DESCRIPTION OF THE WORK:** The primary trail for the North Campus Open Space Multimodal Trail project is approximately 6,300' long and 10' wide. There are 4 proposed crossings (A, B, C & D) along the primary trail, two of which are prefabricated steel bridges defined as crossing C and D. Bridge C is located on the eastern arm of Devereux Slough and is 200' long and 12' wide, supported on concrete abutments and intermediate support founded on CIDH piles. Bridge D is located on Phelps Creek and is 100' long by 12' wide, steel bridge that is supported on concrete abutments and founded on CIDH piles. The construction of the concrete abutments, intermediate support, and trail work is by others. The scope of work for this contract is for the provision of two prefabricated bridges C and D as "owner supplied" items that will be installed by others (installation contractor). The firm offering the lowest responsive bid will be awarded a Purchase Order agreement that will be assigned to the installation contractor. The estimated cost for the specified bridges, inclusive of tax, delivery and all applicable direct and indirect charges or fees, is in the range of \$475,000 to \$525,000.

**AWARD/ASSIGNMENT OF PURCHASE ORDER:** University will determine the lowest responsive Bidder on the basis of the sum of the Lump Sum Base Bid as stated in the Bid Form, if any. University will notify the apparent lowest responsible Bidder of its selection. The successful Bidder and its Subcontractors, if any, will be required to follow the nondiscrimination requirements set forth in the Bidding Documents.

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be required to show evidence of its equal employment opportunity policy.
