Subject to conditions prescribed by the undersigned, sealed bids for a Lump Sum Contract are invited for the following Work:

DESCRIPTION OF WORK: Building 406 (aka "El Centro") is an existing modular building of approximately 1,500 sq. ft. located on the University of California Santa Barbara's main campus. El Centro will be undergoing renovation which must be complete prior to commencement of the University's Fall 2017 school year.

Separate contracts will be awarded for the various elements of the El Centro renovation project Work. The Work required by this Contract, if awarded, will require the contractor to perform foundation, site work and framing repairs, as detailed in the plans and specifications. The University Representative will coordinate the separate contracts.

Estimated Construction Cost: \$94,500

Construction Documents will be available to the invited bidders on **June 21, 2017** via electronic download on a password-protected, private planroom page on the University's online planroom at <http://ucsbplanroom.com/>. Once registered on the UCSB planroom site, prospective bidders may view and/or download Construction/Bidding Documents for free.

To access those documents, simply go the University plan room site, click "Private Jobs" under the Menu bar on the left side of the web page, and enter the Job Key "**site**" (all lower case, no quotes). The posted documents must be evaluated by the participants prior to the scheduled pre-bid meeting.

For construction value between \$300,000 and \$640,000, Bidder AND its mechanical, electrical and plumbing subcontractor(s) (if using) shall be qualified under the University's standards prior to award. See Supplementary Instructions to Bidders for additional information.

The work described in the contract is a public work subject to section 1771 of the California Labor Code. No contractor or subcontractor may be listed on a Bid for this project (submitted on or after March 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 [with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a)].

No contractor or subcontractor may be awarded any portion of this project (awarded on or after April 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5. This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

A mandatory Pre-Bid Conference and mandatory Pre-Bid Job Walk will be conducted on **June 26, 2017** beginning promptly at **1:30PM**. Participants shall meet at

The successful Bidder will be required to have the appropriate State of California Contractor's license current at the time of submission of the Bid.
