## **REQUEST FOR BIDS**

To: Prospective Bidders

Sealed Bids are requested to be submitted to The Regents of the University of California (“University”) on or before **March 6, 2018 by 2:30 p.m.** (the “Bid Deadline”) for the provision of the specified work and in accordance with the enclosed Bidding Documents.

**RFB NUMBER:** FM180294B/981780

**PROJECT NAME:** Henley Hall East Driveway Improvements

**DESCRIPTION OF THE WORK:** Provide all labor, materials, equipment, tools, transportation, insurance and services to widen the existing 10’ wide driveway to 20’ wide per sheet C4.1 (see Exhibit C) including all traffic control and safety measures.

**RFB DOCUMENTS.** RFB Documents will be available to Bidders on February 27, 2018 via electric download from the University’s online planroom at [www.ucsbplanroom.com](http://www.ucsbplanroom.com). Once registered on the UCSB planroom site, prospective bidders may view and/or download the documents for free. In order to access the documents, go to the planroom site, click “Private Jobs” below the Menu bar on the left side of the page, and enter the Job Key “**driveway**” (all lower case, no spaces or quotes).

**COST ESTIMATE:** The estimated construction cost is \$25,000.

**LICENSE REQUIREMENT:** A – General Engineering

**JOB WALK & UNIVERSITY CONTACT INFO:** A Job Walk is not required as a prerequisite to submitting a bid, however, interested bidders may schedule a site visit with the University Representative upon request. **COMMUNICATIONS:** Please make requests for clarification or interpretation of the Bidding Documents only to the University Representative at the above email address. Bids must be submitted on the enclosed Bid Form. Bids may be withdrawn prior to the Bid Deadline. University may waive non-material irregularities or may reject any or all Bids.

**AWARD:** University will determine the lowest responsive Bidder on the basis of the sum of the Lump Sum Base Bid and any extended unit prices, if any. The firm offering the lowest responsive bid will be awarded a Brief Form Agreement (see Exhibit B).

The work described in the contract is a public work subject to section 1771 of the California Labor Code. No contractor or subcontractor may be listed on a Bid for this project unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 [with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a)].

No contractor or subcontractor may be awarded any portion of this project unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5. This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy.
